Registration Fee

The fee for W.Y.S.L registration is based on your child's age as of August 1st, 2011 and is as follows:

In-House

If your child is between **5 and 10** years old on **August 1, 2011**, they will play "in- house". This means they will play other co-ed teams from Whitman. **Practice will start in mid June.**

All groups are based on grade level in the fall of 2011

- Kindergarten and 1st grade (all Kindergarteners must be 5 by August 1st) (Wednesday night games)
- 2nd and 3rd grade (Tuesday Night Games)
- 4th and 5th grade (Monday nights games, they also had some Thursday night games.)
4th and 5th grade teams will have a game or two against Naples as well. Travel is possible.
- 6th graders that turn 11 after August 1st 2010 may still play in-house or move up to the Wayne League

Wayne League

If your child is **11 or older** by **August 1, 2011**, he/she will play in the **Wayne league**. This League is a competitive league which plays against other teams in Ontario and Wayne Counties. These teams are **not co-ed** and require a photo ID player pass issued by the league. Travel to other schools for away games is a requirement. All home games are played on one of Whitman's fields.

Fee includes full uniform, insurance and overhead. Parents are responsible for FIFA approved shin guards and players are encouraged to bring a ball to practice. No child will be allowed to play without shin guards. The season begins in June and goes until August 1st.

Fall CASL League – 4th, 5th and 6th grades Cost is \$50

Players that are entering into 4th, 5th and 6th are eligible to play in the CASL Fall League. Games start in mid September and continue to the end of October. Games will be played on Sunday afternoons at Baker Park in Canandaigua. This is a recreation league that will play teams from other towns like Canandaigua, Bloomfield and Geneva. Teams will practice at least once a week starting in Sept. until the end of the season

Registrations for the fall league will take place through Mid August.
